HB 2103 (signed)

HB 2338 (vetoed)

Aggravated Assault for grabbing your firearm.

HB 2339 (vetoed)

CCW permit holders exempt from "No Firearm" sign if no screening in state & local gov't bldgs.

HB 2483 (signed)

Strengthen lawful use of firearms on private land.

HB 2517 (vetoed)

Penalties for cities and counties violating state preemption laws.

HB 2535 (signed)

Facilitates NFA transfers.

SB 1063 (held in Rules)

If no storage lockers, then "No Weapons" sign invalid in State & local gov't bldgs.

SB 1366 (vetoed)

Standardized firearm definition.
