**Description of Bills**

**SB 1241**

Closed loophole that allowed local jurisdictions to destroy forfeited firearms.

**HB 2457**

Removes prohibition from carrying a weapon (i.e., for self-defense) other than the one authorized for hunting.

**HB 2640**

Game and Fish cannot limit magazine capacity.

**HB 2728**

Use of sound suppressors is now allowed when hunting.

**HB 2729**

Improved safety for law-abiding citizens in state and local government buildings. (Vetoed by Governor Brewer)
