## 2009 Legislative Update



With a new Republican Governor and a Republican controlled Legislature, the beginning of the 2009 legislative session looked promising. Unfortunately, almost the entire session has been devoted to the 2009 and 2010 budgets. Session deadlines for assigning and hearing bills have come and gone, with "promises" to extend them after the budgets are resolved. Meanwhile, some legislators are starting to grumble about leaving before hearing any non-budget legislation. The Arizona Constitution requires a vote from the majority of the legislators in each chamber to pass. If a handful of legislators decide to leave, and the required votes aren't there, the session is effectively over.

In the House, some non-budget bills have been heard in committees and a few have actually been sent to the Senate. The following is the status/fate of key pro-rights bills in the House.

**HB 2171**, a "Restaurant Carry" bill, missed the deadline for being heard in committee. A similar bill, SB 1113, still has a chance in the Senate.

**HB 2174**, which allows the carrying of firearms on game refuges by CCW permit holders, passed out of the House Committee of the Whole (COW) on May 6, 2009. From here, it waits to be calendared for the House Third Read (final vote before being transmitted to the Senate).

**HB 2439**, the AzCDL-requested bill that provides for an alternative 4 hour CCW course for first time permit applicants with prior firearms training, passed out of the House and was transmitted to the Senate on May 6, 2009.

**HB 2474**, which prevents any private or public employer, property owner, etc. from banning any person from keeping a firearm in a locked vehicle in a parking area on the property, with specific, limited exceptions, passed out of the House and was transmitted to the Senate on May 13, 2009.

**HB 2607**, this year's AzCDL-requested "Campus Carry" bill, missed the deadline for being heard in committee.

In the Senate, non-budget bills have not been assigned to any committees while the Senate works on the 2009 and 2010 budgets. The following are important pro-rights bills stuck in this legislative limbo.

**SB 1270**, the AzCDL-requested bill that removes the penalty for the lawful carrying of a concealed weapon without a permit.

**SB 1243**, the AzCDL-requested bill that clarifies when a defensive display of a firearm is justified.

**SB 1113**, A Restaurant Carry bill that permits firearms in certain restaurants if signs are not posted forbidding firearms, and the person possessing the firearm does not consume alcohol.

When the 2010 budget finally passes, the Senate is facing a tsunami of non-budget bills conflicting with their urge to end the session and go home. AzCDL's full-time volunteer lobbyists continue to meet with key legislators on strategies to prevent critical pro-rights bills from being axed to accommodate streamlined scheduling. We will not go quietly into the night!



# Pending Federal Legislation



AzCDL focuses on Arizona legislation. There are many national firearms related organizations, starting with the 4+ Million member NRA, constantly reporting on what is going on at the National level. We urge everyone to pay attention to the news coming out of the major national firearms groups.

Since the current President and Congress have the majority needed to administratively and legislatively thwart our Right to Keep and Bears Arms (RKBA), the following are the more significant Federal assaults on our liberty that we should all be aware of.

## Gun Owners = Extremists

The Department of Homeland Security (DHS) Secretary, former Arizona Governor Janet Napolitano, recently issued an "assessment" that firearms owners, along with veterans and people holding right-of-center beliefs, pose a threat to our National Security.

## Registration & Licensing

HR 45, the "Blair Holt's Firearm Licensing & Record of Sale Act," calls for gun owners to apply to the federal government for screening, testing and registration. Currently HR 45 appears to have no support aside from its sole sponsor, former Black Panther co-founder Bobby Rush.

## Regulating Private Sales

S 843 imposes restriction on gun shows that include background checks on all private firearms transactions. It would also require federal registration of gun show promoters and vendors.

## Permanent Cosmetic Features Ban


Described as the "assault" weapon ban on steroids, HR 1022 makes permanent the expired ban on popular semi-automatic rifles and pistols with certain cosmetic features. Standard capacity magazines would also be banned.

## Repealing the Tiahrt Amendment

Within hours after being declared president-elect, the Obama transition team website announced anti-rights initiatives designed to ban guns and drive law-abiding firearms manufacturers and

dealers out of business. One of those initiatives called for the repeal of the Tiahrt Amendment, which prohibits the release of federal firearm tracing information to anyone other than a law enforcement agency. Rights prohibitionists want the tracing data to persecute law-abiding firearms manufacturers.

Other initiatives President Obama supports are a permanent "assault" weapons ban, closing the gun show "loophole" and making guns "childproof," which is the code word for expensive and impossible to comply with design requirements.



## CIFTA

On his recent "Blame America First" visit to Mexico, President Obama promised to get the Senate to ratify an international treaty, known as CIFTA, that could have far-reaching effects on U.S. gun ownership, without needing to pass additional legislation.

CIFTA was signed by President Clinton but has yet to be ratified by the Senate. If ratified, the conditions of the treaty become mandatory and override existing federal law (as specified in Article VI of the Constitution). It calls for the registration of firearms, ammunition and ammunition components. Reloading ammo would become illegal. Same with modifying (customizing) a firearm. Firearms records that must now be destroyed or cannot be shared would be stored online internationally for easy access.

## When will all this happen?

Despite the Democrats controlling the Executive and Legislative branches of the US Government, anti-RKBA legislation doesn't have a majority of supporters—for the moment at least. Many newly elected Democrats defeated their Republican opponents by displaying conservative and pro-RKBA characteristics. Hopefully, many long-term Democrats also remember the many defeats caused by attacking gun owners in past elections. Let's hope that sanity prevails.

## Some Good News

The United States Court of Appeals for the Ninth Circuit, covering Alaska, Arizona, California, Hawaii, Idaho, Montana, Nevada, Oregon and Washington, ruled in *Nordyke v. King*, that the 2nd Amendment is "incorporated" through the 14th Amendment. This means that the Second Amendment is a right protected at the state and local levels for residents in the states under the jurisdiction of the Ninth Circuit.

Buried in the credit card "reform" act, recently signed by President Obama, was an amendment that restored the right to possess firearms in National Parks. However, implementation of the new law will be delayed for 9 months because the underlying bill contains the delay to allow credit card companies to adopt their new rules.

All nomination requests must be received by AzCDL by June 30, 2009. Any nomination received after June 30, 2009 will not be placed on the ballot.


If you include a candidate biography and/or a statement of why they/you should be elected, it must be limited to a single 8.5" x 11" page using standard margins and line spacing, and a font size equivalent to Arial 10. Any legitimate candidate statement timely received will be made available to members during the balloting process.
