Defending Your Rights



Can what happened to George Zimmerman in Florida happen in Arizona?

It already has. In 1997, Arizona's Republican controlled legislature, at the behest of law enforcement, passed a law negating "innocent until proven guilty" in self-defense situations. The new law required that anyone who defended themselves had to admit to the underlying "crime" then prove their own innocence by a "preponderance of evidence." As with all laws making it easier for law enforcement to avoid real police work, the unintended consequences were brutal.



In May 2004, Harold Fish, a retired school teacher, was forced to defend himself by shooting an unarmed attacker. As with the Zimmerman case, initial police investigations recommend that no charges be filed. However, the Coconino County prosecutor insisted on bringing criminal charges. Unlike George Zimmerman, with state law against him, Mr. Fish was convicted of second degree murder and sent to prison. In 2006, with AzCDL's support, legislation was introduced and passed into law that restored our right to be "innocent until proven guilty." Unfortunately it wasn't until 2009 that Mr. Fish was released from prison under the "new" law. Sadly, he died just 3 years later.

In addition to restoring "innocent until proven guilty," AzCDL has been instrumental in getting legislation passed that further protects your right to legitimately defend yourself. Among these are:

- Strengthening the elements of justification for the use of force.
- Adding the presumption, in certain civil actions, that a victim acted reasonably when using physical or deadly force.
- Establishment of the justification for the defensive display of a firearm.
- Clarification that a person has no duty to retreat in any place that they have a right to be (i.e., Stand your Ground).
- Strengthening Castle Doctrine.
- A Constitutional Amendment to prevent victims from being sued by their attacker.

However, none of these laws will protect you from a dedicated prosecutor bent on using your case to push an ideological agenda funded with taxpayer money. But with your help we can make it more difficult for them to railroad an honest citizen.



It's going to take everyone pulling together. If Arizona's elected officials truly supported your right to bear arms, they wouldn't ban firearms at the State Capitol and on almost all government property in the state; the Governor and Legislature would not allow Tucson to get away with violating state firearms preemption laws; and your Arizona CCW permit would not refer to the "privilege" to carry discreetly.



Putting pressure on Arizona politicians starts with becoming an AzCDL member, but does not end there. Our lobbyists work full time at the State Capitol championing good legislation and stopping bad bills, but without your <u>active</u> participation, backing them up by contacting committee members, your legislators and the Governor, our efforts would be ignored.



bers. We expect to have over 10,000 members by the start of the 2014 legislative session. That number can carry a lot of weight, but only if everyone reading this commits to spending a little time making a difference. What do we mean by "time?" *Scant minutes and a few key strokes*. As important bills progress, we provide prepared messages at our Legislative Action Center for contacting key officials. Whether or not a bill supporting your right to bear arms moves and gets legislative support can be measured by the volume of emails they receive.

To put it another way, if you do nothing, you're telling committee members, your legislators and the Governor that you are fine with your rights slowly eroding away.

New Laws Effective September 13th

The 2013 Legislative session started on January 14th and adjourned on June 14th. This session we had a legislature with Republican majorities in both chambers.

On the surface, it looked positive for the passage of pro-rights legislation. Unfortunately what we encountered, at the assumed direction of legislative leadership, was a concerted effort to prevent any significant pro-rights firearms legislation from reaching the Governor.

However, with the help of thousands of AzCDL's members and supporters contacting their legislators, committee members, and the Governor, we were successful in getting key bills signed into law.

The following is a summary of the prorights firearms bills that will become law on September 13, 2013.

Gun Owner Registration Blocked

HB 2326 amends ARS 13-3108 to prohibit state agencies and local governments from maintaining *"identifying information of a person who owns, possesses, purchases, sells or transfers a firearm,"* except in the course of a law enforcement investigation (e.g., locating a stolen firearm).

In light of government maintained registries being used to confiscate firearms in California, New York and other states, HB 2326 is timely and important.

Firearms Destruction Stopped

Last year, AzCDL-requested legislation was passed that forbade local municipalities from destroying firearms that had been "recovered, lost or abandoned." Using Clintonesque (depends on what "is" means) rationalization, the cities of Tucson and Phoenix reasoned that current law does not prohibit the destruction of firearms "surrendered" as a result of a "buy back" program.

To counter this, **HB 2455**, which contained AzCDL-requested language, was passed and signed by the Governor that clarifies that firearms "surrendered" or "otherwise received" fall under the definition of property that must be sold and not destroyed.

Support for the 2nd Amendment

The final pro-rights bill that passed the Legislature was **SCR 1015**, a resolution

by the Legislature that they support "the right under the Second Amendment of the United States Constitution of individual citizens to keep and bear arms and reject the consideration of new legislation that would infringe on this constitutionally protected right."



Despite all members of the Legislature swearing to uphold the U.S. and Arizona Constitutions, SCR 1015 passed by small majorities in the House and Senate. While SCR 1015 is a welcomed gesture, it has no legal effect.

A real show of support for the right to bear arms would have been the passage of several other firearms related pro-rights bills introduced this session that were allowed to die.

Get' em before they're gone!

AzCDL is raffling off <u>two</u> AR-15's and a case of 5.56 NATO ammo in three separate raffles.

The first rifle is a Colt Light Carbine, chambered for .223 Remington, with a non-lined 16" barrel and bird-cage flash hider. This rifle is optics ready with a flat top. A standard capacity 30 round magazine is included.

The second rifle is a DPMS Panther A-15, chambered for 5.56 mm NATO, with iron sights, a 16" barrel, and a 6 position stock. A standard capacity 30 round magazine is included.

500 tickets have printed for each rifle raffle with a drawing date of Sunday, September 15th. *Over half the tickets have already been sold.*



Winners must comply with all federal, state and local laws, and must pick up their firearm from a federally licensed firearms dealer.

The final raffle is a case (1,000 rounds) of British 5.56 mm ammunition, produced at their Radway Green plant in March 1998. This case is sealed in the original wooden box and has never been opened.

The drawing for the winning ticket will occur when all the tickets have been sold. *As this was being drafted there were only 130 tickets left.*

The winner of this raffle must retrieve the ammunition in Tucson, or make arrangements to have it shipped.
