A Bright Future Ahead

A few months ago, AzCDL suffered a tremendous loss in the passing of our President Emeritus and one of the original founders of the organization, David Kopp. After a battle that lasted more than a decade, Dave eventually succumbed to cancer. If it comes as a surprise to you that he was even ill, you are not alone—Dave was not one to burden others with his personal struggles.

To longtime members of AzCDL, Dave was more than just our president, he was a visionary, a mentor and, of course, a friend. Well respected by members of the legislature on both sides of the aisle, Dave did not mince words and was sometimes downright gruff. But he was also a diplomat for the right to keep and bear arms and knew how to play the game of politics expertly.

At the legislature, Dave worked closely with others, particularly AzCDL cofounder John Wentling. Their accomplishments speak for themselves—the Castle Doctrine and burden of proof legislation, the "Katrina bill", defensive display, secure storage requirements in public buildings, and perhaps most significant of all, Constitutional Carry. In all, Dave and AzCDL have had 62 pro-freedom bills enacted into law under three different governors while stopping literally hundreds of anti-freedom bills from seeing the light of day.

Seventeen years later, AzCDL has grown from the original 4 founders to over 21,000 members and is widely regarded as *the* gun lobby in Arizona. Guns & Ammo magazine recognized Arizona as having the best gun laws in the country eight years in a row.

Dave knew his time was short and he spent much of what remained making sure that the legacy he and his fellow founders established would live on. He hand-picked the team that would take over for him then mentored and coached us. He did his best to impart a vision for AzCDL's future that would continue the organization's legacy.

Dave's passion for freedom lives on in AzCDL's board of directors and officers. President Michael Gibbs was previously Vice President for 4 years, and is a registered lobbyist for the organization, having trained with Dave for 3 years at the state capitol. Vice President Cheryl Todd is the state director of the DC Project, a former gun store owner, and host of Gun Freedom Radio. Secretary, treasurer and longtime director Tom Woodrow, the guy that literally keeps the organization running, was personally trained by the man that literally defined the job, retired AzCDL director Fred Dahnke. Duke Schechter continues as a director and our membership recruiter extraordinaire. Charles Heller, one of the original founders, remains our Media Coordinator, and we have enlisted the expertise of David Laird as our social media guru.

Michael Infanzon of EPIC Policy Group will be taking the reins as our full-time, professional lobbyist at the capitol. Mike worked with Dave Kopp for many years and knows the job well. Like Dave, he is well known within the legislature and will get things done for AzCDL.

In short, AzCDL is in good hands and will continue to do the good work that you have entrusted to us. But you, our members, must also play a part in our continued success. Our influence at the legislature comes from our numbers and that's where you can help. Talk to your friends and ask them to join AzCDL. Volunteer at a gun show or other event and help spread the word. And make sure that you engage with your senator and representatives when we send out our legislative calls to action. With your help, AzCDL's future continues to look bright.

Lifetime Achievement Awarded to Dave Kopp



We have all heard the cautionary advice that we should never meet the people whom we admire. We are told that these heroes can only disappoint us and they will be too human to live up to the pedestal on which we place them. Dave Kopp was absolutely the exception to that rule. Few people have made such a positive impact on my life and my work as did Dave Kopp, and I know thousands

of people share my experience. I visited Dave a few days before he passed away and, without knowing that it would be the last time we spoke, I came away with a profound sense of having been blessed with a mentor, a cheerleader and a friend.

Dave Kopp passed away after a long battle with cancer, and I am convinced it was the only fight he ever did not come out as the victor. Dave was smart, well-read, well-connected, and made a powerful impact in every matter to which he put his mind. His intellect was matched only by his humility. Dave was the epitome of speaking softly, but being very able to wield the big stick of wisdom, knowledge, drive and purpose.

Dave was both a co-founder and President of the AzCDL. He had deeply held values of Individual Liberties that guided and informed his leadership style. Even when he had every right to invoke his title, his power, his experience or his personal wishes over others he chose the open-handedness and open-mindedness of someone confident and comfortable with his place in the world. The work to which Dave Kopp dedicated his life, alongside the Board of Directors and members of AzCDL, has made

the State of Arizona more freedom-oriented and respectful of individual rights for generations to come. We all owe Dave a debt of gratitude for his tireless commitment and work.

Knowing all of these things about Dave, it therefore was not surprising that he was posthumously awarded the 2022 Lifetime Achievement Award by the Citizens Committee for the Right to Keep and Bear Arms (CCRKBA) at the 37th Annual Second Amendment Foundation's Gun Rights Policy Conference (GRPC). What was a tremendous and unexpected honor was that I was invited to accept this important award on behalf of the AzCDL, my fellow Members of the Board and Dave's family.

Dave had been an invited Speaker every year at the GRPC and had been awarded multiple times, including being named the Grassroots Activist of the Year. If he had not been ill this year, he would have once again been updating the attendees about the state of grassroots activism in Arizona, and encouraging leaders in other states to persevere in the goals of defeating bad legislation and supporting pro-freedom legislation. As a matter of fact, the first words I ever heard Dave speak were from the podium at a GRPC when he challenged the audience, "If you are a gun owner in the State of Arizona and you are not a member of the AzCDL...why not?!" I remember it so clearly because at the time his challenge landed firmly on my own conscience. I very quickly became a Life Member as well as an outspoken advocate for the work of the AzCDL.

I am but one of many thousands of people who share in having been blessed in some way by knowing Dave Kopp, working with Dave, or simply living in the state of Arizona where Dave's work kept freedom alive. Please join me in celebrating a life well lived and well-remembered for all the reasons why Dave Kopp's work has been recognized and honored with the 2022 CCRKBA Lifetime Achievement Award.

Copper Dome Update

What a difference a day makes!

Yesterday, we were looking at what type of bills could we get through a slim majority legislature and onto the desk of an untested, but verbally supportive of pro-freedom bills, Governor Lake. Today, we may well be looking at some of the same bills but preparing for a more defensive strategy in case an anti-firearm bill happens to make it to the desk of a Governor Hobbs.

Trickle down freedoms?

We know, based upon Katie Hobbs' tenure in the state legislature, that she is not the most firearm friendly person around. In fact, then-Senator Hobbs voted against almost every single one of our bills when she was a legislator, if not all of them.

With all of these things in mind, rest assured that the AzCDL has a bevy of strategies at the ready to get bills passed that protect and advance our Constitutionally protected freedoms.

As I shared with you at the AzCDL Annual Meeting in October, we will be advocating for these pieces of legislation:

- 1. Firearms safety training for school aged kids
- 2. College/University Campus carry
- 3. Firearms industry banking protections
- 4. Misconduct involving weapons; public buildings
- 5. Sales tax elimination for weapons and ammunition

Of course, we will be defending the rights and freedoms we currently have. This will be a critical time in Arizona. It won't be easy to get legislation passed and signed by this legislature and governor, but the Arizona Citizens Defense League is **strong**.

WE ARE THE FIREARM RIGHTS PROTECTION IN ARIZONA!

We do have some strong allies in the state legislature, and we plan on using these alliances to keep the wolves at bay. In the meantime, we will be asking for your help.

The legislature's Request to Speak system is a highly effective way for citizens to engage with their senator and representatives, whether in-person or from the comfort of home. AzCDL assists with the creation of new RTS accounts and re-activation of accounts that have gone dormant (which must be done at the state Capitol or via remote kiosks in Tucson). It's always helpful to find volunteers willing to spend a little time in one of these locations to assist their fellow members in making their voices heard with our legislators.

We are always in need of help to staff booths and tables at gun shows and other events around the state.
